## 2025 SMAR AWARDS OF EXCELLENCE GENERAL RULES

### 1. DEADLINE:

- a. Applications must be received no later than Monday, February 23, 2026, at 4 pm to be eligible for consideration by one of the following methods:
  - i. Electronically to Robin Hoffman at [robinh@somdrealtors.com](mailto:robinh@somdrealtors.com) via DotLoop or ZipLogix (email submissions will not be accepted)
  - ii. Hand deliver to SMAR, 8440 Old Leonardtown Rd, Ste 211, Hughesville, MD. **(BY APPOINTMENT ONLY)**
- b. All entries will be date stamped upon receipt. Late entries will not be accepted after the deadline. THERE WILL BE NO EXCEPTIONS!

### 2. MEMBERSHIP ELIGIBILITY:

- a. Award applicant must hold primary membership in the Southern Maryland Association of REALTORS® (SMAR)

### 3. MEMBERSHIP DUES:

- a. All applicants must currently be “members in good standing” (fully paid member) with SMAR.
- b. Only sales and listing settled while applicant was a ‘members in good standing’ of SMAR will be considered.

### 4. SALES MANAGER:

- a. Members who have served in managerial positions during any portion of the calendar year 2025 are **NOT** eligible to receive awards.

### 5. LEGITIMATE PRODUCTION CREDIT:

- a. 100% of listing and /or selling commission must be earned to receive credit for 100% of production volume.
- b. Transaction may only be applied once if multiple applications are submitted (with the exception of Hall of Fame and Rookie of the Year).
- c. If more than one agent receives compensation from the listing and/or sales side of a transaction, the production must be prorated based upon the percentage of the total commission received (e.g., commission split or referral). This information should be noted in the “remarks” of the MLS or company printout.
- d. Residential Lot Sales may be counted toward the Individual Residential Production Award.
- e. Rentals are not included in production awards.
- f. Commercial Sales can be included in overall production.

## 6. VERIFICATION OF INFORMATION:

- a. Applicants must complete each applicable SMAR Official Awards Application.
- b. Please note there are separate applications for Individual Residential Awards, Residential Team Awards, Commercial Awards, Rookie of the Year Awards and Hall of Fame Awards.
- c. Application must be signed by applicant AND manager/broker. **ORIGINAL OR ELECTRONIC SIGNATURES (NOT COPIES) ARE REQUIRED.**
- d. Applicant must provide information on all settled transactions.
- e. **For "Comp Only" Sales**, a settlement sheet must be provided for anything entered into the MLS or on the company report.
- f. **Each settled transaction must be documented by the following method:**

*Bright MLS Sales report **OR** company report. To generated the Bright MLS Report, please follow these instructions:*

1. Enter Bright MLS web site ([www.brightmls.com](http://www.brightmls.com))
2. Login with username and password
3. Select "Market" on the top menu
4. Click on "Agent & Office Production"
5. Click on "Agent Awards Report"
6. Input start and end dates
7. Add Subscription ID
8. Click on "Generate Report"

- g. In the event there is a question about your submission, a member of SMAR staff will contact the Broker/Manager by phone to discuss concerns. The applicant will have until the close of business (4:30pm) the following day to submit corrections.

## 7. VIOLATIONS:

- a. Any applicant who is found to be in violation of the awards rules and criteria or is found to have submitted any inaccurate or untruthful information will be disqualified.

## SMAR AWARDS OF EXCELLENCE

### *Individual Sales Award Criteria*

Each award applicant may qualify **EITHER** by dollar volume **OR** by number of transactions regardless of dollar volume. Applicants who operate as part of a team are not eligible for this individual award. Refer to Team Awards Criteria.

#### **BRONZE AWARD**

1 Million -1.999 Million dollar volume

**OR**

Completion of at least five (5) settled sale and/or listing transactions regardless of dollar volume.

#### **SILVER AWARD**

2 Million -3.999 Million dollar volume

**OR**

Completion of at least ten (10) settled sale and/or listing transactions regardless of dollar volume.

#### **GOLD AWARD**

4 Million-5.999 Million dollar volume

**OR**

Completion of at least twenty (20) settled sale and /or listing transactions regardless of dollar volume.

#### **PLATINUM AWARD**

6 Million – 9.999 Million dollar volume

**OR**

Completion of at least thirty (30) settled sale and/or listing transactions regardless of dollar volume.

#### **DIAMOND AWARD**

10 Million – 19.999 Million dollar volume

**OR**

Completion of at least fifty (50) settled sale and/or listing transactions regardless of dollar volume.

#### **DOUBLE DIAMOND AWARD**

20 Million and over total dollar volume

**OR**

Sixty (60) combined settled listings and sales transactions regardless of the dollar volume.

(Applicants for this award negate eligibility for individual production awards.) **Teams shall be defined according to the criteria established by the Maryland Real Estate Commission (MREC)**

An agent who uses a licensed assistant to do clerical work-i.e., preparing brochures, entering listings, taking pictures, and other general clerical services, is not required to submit the licensed assistant's name for the award. Applicants who assist another agent on a referral basis do not necessarily constitute a team and are eligible for individual awards categories. (Referral percentages may be noted on the application worksheets.)

### *Rookie of the Year Award Criteria*

Each county (Calvert, Charles, and St. Mary's is eligible to have one "rookie" winner. **The "Primary Office" is defined as the Broker's office address according to DLLR.**

Applicant must have COMPLETED FIRST FULL LICENSE YEAR any time during the calendar year 2025 (**For example:** An agent may have become licensed in June 2024 and finished their FIRST FULL LICENSE YEAR in June 2025).

Transactions that occurred during their FIRST FULL LICENSE YEAR (ex: June 2024 -June 2025) must be provided. Only settled transactions relating to the applicant's FIRST FULL LICENSE YEAR (ex: June 2024 -June 2025) will be considered.

Broker/Manager must verify date when applicant became licensed as well as provide verification for all applicable settled transactions.

**Criteria is based on number of settled transactions.** In the case of a tie, the award goes to the highest dollar volume. Rentals are to be included.

Applicants may participate simultaneously in this category and other individual categories if all applicable qualifying criteria are met, and separate applications are submitted.

Applicants are only eligible for "Rookie of the Year" if they are a first-year-licensee and have not previously been licensed in Maryland or in any other Jurisdiction.
